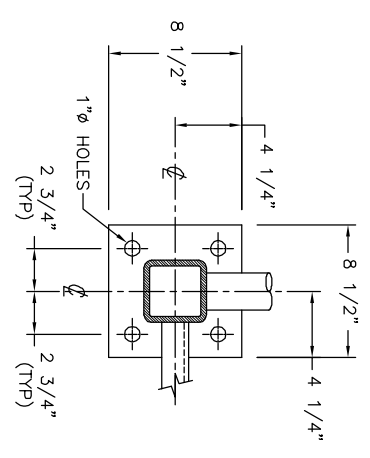
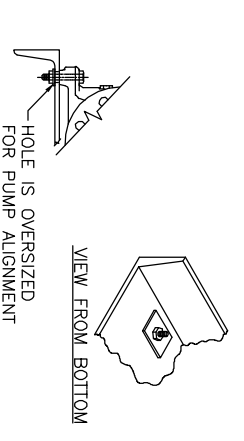


SADDLE WELD DETAIL
